Key Milestones


- Dusk Network was founded in early 2018. Its primary office is located in Amsterdam, Netherlands.
- Dusk is still in its early stage, and is backed by venture capitals, including Maven 11, GSR, Blockwall, Wentworth Hall Family Office, Olymp Capital, Blockground, CryptoLabs, CipherBlade, The Reserve and iFinex.
- The investors raised \$8,075,557 for the first stage private sale. The private sale raised 140,200,637 tokens, which is approximately 56% of the total token distribution.
- In August 2019, Dusk published Whitepaper V2.0 with updates on the network's performance and versatility.
- In May 2020, Dusk finished the implementation of PLONK. PLONK is a zero-knowledge proof system, and the new technology expands the platform's utility from security tokens to complex dApps and various other DeFi-related use cases.

Jurisdiction

Dusk is designed for compliance with global regulation and local legislation.

Technology

Transactions can be settled within 15 seconds on Dusk's platform. Utilizing zero-knowledge cryptography, Dusk designed Proof-of-Blind Bid to preserve privacy in the network. The protocol protects both privacy of users and confidentiality of the data being exchanged. Proof-of-Blind Bid protocol represents a more efficient Proof-of-Stake, and it additionally preserves the anonymity of the participants of the protocol execution trace and the values of the corresponding stakes.

Dusk applies a "Segregated Byzantine Agreement" (SBA) consensus mechanism. SBA combines exciting ideas like cryptographic sortition (lottery), stealth time-locked transactions (private stake

amounts) and a reputation module to increase the chances of selecting honest nodes and further promote decentralization.

Traction

The first STO launched on Dusk Network is BWRE, a Maltese short stay real estate company. The issuance is worth €21 million of tokenized equity. BWRE identifies undervalued properties and renovates them into trendy short stay accommodations. With Malta's 15%+ yearly growth in tourism, BWRE targets a return of 10%+.
